Program Description :

Admission Requirement :

1. Students must receive 60% or higher in the equivalent undergraduate course.
2. Students are expected to have taken foundations of Math 12 or Pre-calculus 12 (or equivalent). Those who have not done so can still be admitted to the program, but they must complete equivalent courses as approved by a program advisor.
